NOTIFICATION

The Governor is pleased to transfer 70 (seventy) officers of West Bengal Audit & Accounts Service as shown in **Column -2** in the given Annexure and appoint them to the post as noted against each of them in **Column-3**. This order **cancel** / **modifies** the earlier notifications to the extent they relate to the officers/postings mentioned in this Notification.
